OTHER OPTIONS

- **10-Play:** A 10-play golf option is available to Associate and Social members at a current cost of \$450. The 10-Play option permits play of up to 180 holes (in 9-hole increments) at any time except Saturday and Sunday before noon, and Wednesday and Friday between 11 AM and 3 PM. Social members may not participate in club tournaments or as substitutes in a league. The 10-Play option is valid only for the year purchased. Any unused rounds at the end of the year are forfeited.

- Applicants will be notified of acceptance or rejection.
- All memberships have a minimum annual spending amount required in the Club dining room. The rate is \$400 for multiple person memberships and \$200 for single person memberships. Only food purchases charged to your account will be applied against the minimum. Members will have twelve (12) months from January through December to apply food purchases to the minimum. If total food purchases are less than the applicable minimum, the member will be billed for the difference.
- The Board of Governors has the right to request resignation or to terminate the membership of any member for (1) Nonpayment of dues or other Club indebtedness, including assessments, charges, and/or damages; (2) infraction of Club rules; or, (3) improper conduct.
